1. OVERVIEW OF CIGAR INDUSTRY IMPORTS

1.1. Large Cigars

The table below includes all four large cigar import HTS codes from the U. S. Census Bureau, Imports of Merchandise for Consumption IM-146 Report. As of September 30, 2023, imports year-to-date decreased by about 820 million cigars (down 12%) when compared to 2022 year-todate. For a more detailed picture of large cigars imported, the graph on page 2 shows a YOY comparison of the four large cigar HTS import codes.

1.2. Little Cigars and Cigar Leaf Tobacco

As of September 30, 2023, little cigar imports year-to-date increased by 13 million cigars (up 22%) when compared to 2022 YTD. During the same period, imports of cigar leaf tobacco year-to-date decreased by 1.7 million kilograms (kg) (down by 11%) when compared to 2022 YTD.



Large cigar imports in 2023 YTD were 6.3B as compared to 7.1B in 2022 YTD.							
At the end of September 2023, total large cigar imports decreased by 820M (down 12%) YOY.

SUMMARY: Comparing 2023 with 2022 YTD, the only category that continues to show a YOY increase is the HTS code x6000 (\$.15-.229) which was up by 2% at the end of September 2023. By the end of September 2023, the HTS code x3070 (<\$.15) showed a decrease YOY of 820 million cigars or down by 12% which is a slight rebound from the prior month.

3. OVERVIEW OF PREMIUM CIGAR IMPORTS

Premium cigars account for just about 4% of the total cigar market (i.e., large cigars and little cigars). Imports of premium cigars are included in two of the four large cigar HTS codes in the U.S. Census Bureau IM-146 Report: 1) HTS Code 2402.10.8050 (U.S. Customs value between \$.23 and \$.76) and 2) HTS code 2402.10.8080 (U.S. Customs value of more than \$.76). The other two large cigar import HTS codes include only popular price or mass market large cigars.

The key supplier countries for premium cigar imports listed in these two HTS codes include the Bahamas, Costa Rica, Dominican Republic, Honduras, Mexico, Nicaragua, Panama (no activity in 2022 and so far in 2023), and the Philippines.

From January – September 2023, there was a total of **347.1 million cigars** imported from these eight countries. Within these two HTS codes, popular price or mass-market large cigars are included. CAA uses data from our manufacturer members to exclude mass-market large cigars from these HTS codes. Since CAA manufacturer members represent most companies of the large cigar market, excluding their import data of mass-market large cigar imports in these two HTS codes provides a better estimate of total premium cigars.

For this period, CAA estimated that premium cigar imports amounted to **338.9 million cigars**. As of the end of September 2023, CAA excluded 8.2 million mass-market cigars imported from the Dominican Republic that were included in HTS codes 2402.10.8050 and 2402.10.8080.



When comparing September 2023 YTD with the same period in 2022, premium cigar imports have a slight decrease from 2022 of just under 1%. At the end of August 2023, premium imports were down 3.2% as compared to 2022 for the same eight-month period. On the next page, there is a monthly comparison of premium imports in 2023 with 2022.

Estimated Premium Cigar Imports

The bar chart above for Estimated Premium Cigar US Imports shows a 14% increase for the month of September. As of the end of September, premium imports were down just under 1% for the year when compared to the same period in 2022. The premium market remains resilient.

The low point of the year so far was at the end of April when premium imports were down almost 7% when compared to the first four months in 2022.

By the end of September 2023, premium imports have climbed back to almost a breakeven level by being down just under 1% when compared to 2022 for the same period.

SUMMARY

While popular price, mass market large cigars are down about 11% as of the end of third quarter in 2023 when compared to the same period in 2022, premium cigar imports are down less than 1% when comparing Q3 2023 with Q3 2022. The strong import years for premium cigars in 2021 and 2022 appear to be continuing into 2023.
